THE AGREEMENT A MINI RESCUE'S PHILOSOPHY IS, A PET IS FOR LIFE!!

The purpose of this application is to ensure that both the animal and potential new family are matched for a long and rewarding life together. At A Mini Rescue, we are committed to the safety and well-being of our rescued animals. We appreciate that all situations are different and will consider all applications equally. Submission of this application does not guarantee adoption of the stated animal, all applications are carefully reviewed and a decision is provided to the applicant as soon as practicable

I understand that I am entering into a binding agreement between myself and A Mini Rescue for adopting a rescue animal. I confirm that I have read this entire agreement carefully and fully understand all aspects before signing (*Please tick to confirm you understand*).

I agree that this pet is being adopted as a companion pet. That the pet will be provided with proper food, water, shelter, exercise, immunisations and necessary veterinary treatment. That the pet will be given a loving home. I accept responsibility for completing desexing at no later than 6 months of age. I will arrange transport to and from vet myself	
The pet has been examined by A Mini Rescue partner veterinarian prior to his/her adoption and has received vaccinations appropriate for the age or time in care. A Mini Rescue will provide copies of these records on completion of the adoption.	
If the animal is currently under veterinary care, I confirm that I have been notified of any current medical Conditions as far as A Mini Rescue has been made aware and I understand that any veterinary problems that now may arise with this pet, including serious illnesses requiring emergency care or surgery and costs are now my responsibility.	
I understand that in the event that I can no longer keep the animal, due to injury, illness, accident or any other reason and are unable to fully care for the pet, I will notify A Mini Rescue immediately and will work with A Mini Rescue to place the pet in an approved home. However, I understand that the adoption fee is non-refundable.	
I agree to register my pet with my local council and maintain current pet registration on reaching 12weeks old as per the "Animal Management (Cats & Dogs) Act 2008 QLD" or applicable regional legislation.	
I commit to keeping my cat as an indoor cat only	
I understand that a Mini Rescue is not responsible for any liability costs or damage(S), including vet costs (except for scheduled vet visits or illnesses that had been apparent before adoption) during the settling in period and when the adoption has been completed. I indemnify A Mini Rescue, its employee and volunteers from any and all liabilities, costs and/or damages by fault of this pet which arise as a result of my actions or omissions(including negligence) after the time of adoption. These damages include, but are not limited to, destruction of property and/or physical damage to any person or group of people. In the event that the adoption is occurs interstate, the point of transfer of responsibilities occurs at the delivery of the pet to transport company (i.e.: Airport / Courier).
